This is a time for the club to participate and come together in fellowship with members and other clubs.

By Laws committee – Sheila Walker, Chair – The committee has received the revised By-Laws for review and a meeting will be scheduled to make final revisions and then a special meeting will be held to present the newly revised set of By-Laws to the membership for approval.

Membership Committee – Carol Pettigrew, Chair - No Report

Entertainment Committee – Ronnie Gregory, Chair – Area Party was held June 11th, was a lot of fun and a huge success. Breakdown of funds will be provided in the newsletter. Hugh Walker attended a Moose meeting shortly following the event and they enjoyed working with our club.

Christmas Party: Ballots were passed out to vote on DJ for the Christmas Party. The DJs listed were Johnny Wilson, Clyde Waller, Jerry Holland, Jim Waye and Tootie Brown. Sheila contacted all of these DJs beforehand to make sure they would be available. The club voted by ballot and Jim Waye will be the DJ for 2005 Christmas Party.

Meals on Wheels: A special meeting was held between the membership and Anne Baker where Anne gave a presentation on Meals on Wheels and Al Fogleman discussed concerns about the event. Evelyn Turner took the

minutes of the meeting and they will be posted in the July Shag Rag. The Ramada Inn and Holiday Band are available for the 18th of February, 2006 and Sheila said that the club needed to vote on whether or not to host the event. A motion was made for the club to host the event; it was 2nd and passed with a vote of 22 to 0. A committee will be formed and duties will be split among the members of the committee; this should help in facilitation of communication.

ACSC Summer Workshop: Will be held in New Bern and the dates are July 8-10. If you have not purchased your tickets, do so quickly, they are going fast and only a certain amount will be available. If you need registration forms see Sheila Walker. A preliminary flyer needs to be available at this workshop for the 2006 summer workshop that is scheduled to be hosted by BSC.

- There are several flyers for various events being held by other shag clubs that Sheila has available if anyone is interested in seeing them.
- Membership appreciation pool party was brought up, when will it be held and how much needs to be allocated for the event. Sheila said that we needed to get the Area party behind us before working on the pool party; the committee for this will be meeting soon. A motion was made to allot \$500 from treasury for the event, 2nd and passed with 16 for and 1 opposed. This will be discussed further at the July business meeting.



Special Meeting - Burlington Shag Club/Meals On Wheels Benefit June 6, 2005

Attendees were: Sheila Walker, Hugh Walker, Steve McHone, Charles Lindley, Judy Lindley, Al Fogleman, Cookie Fogleman, Evelyn Turner, Lynda Justice, Anne Haberly, Peg Hanson, Carl Hanson, Carol Oakley, Jonnie Ellington, Judy Smith, Ron Jefferies, Ronnie Gregory, Mary Gregory, Joni James, Denise Upchurch, Chuck Upchurch, Kent Bradsher, Brenda Smith, Butch Dowd, Pam Hord

Meeting called to order at 7:15 p.m. by Sheila Walker. She asked Anne Baker, Director for Meals On Wheels, and Al Fogleman, BSC Benefits Chairman to speak to members present and to take questions.

Anne said she was very appreciative of all the work that our shag club did on the benefits and noted that it took a lot of work to put on an event like this. She advised that MOW has a budget of \$395,000 per year and that it takes \$3,000 per year to feed one recipient. Alamance County Meals On Wheels is the most selected program in North Carolina. The major regulation to be a recipient for Meals On Wheels is that a person have less than 20 hours a week of in-home aid. ACMOW serves 400 meals every day and averages 600-800 different clients during a year. Anne said they were running in negative dollars right now. They have only three full time staff now and two part-time drivers. Other deliveries are made by volunteers.

Cookie Fogleman noted that shag club members should try and get involved and help deliver meals and they would have an opportunity to see how the process works and how appreciative the people are who receive the meals.

Anne's comments and comments from members regarding the 2005 benefit were as follows:

- ◆ Decorations were different than the usual valentine theme. Got positive response from attendees that they liked another theme. Peg Hansen, who was in charge of decorations, commented that she heard good things about the different decorations.
- ◆ Attendance was down slightly and there seemed to be more people in the band room than in the DJ room.
- ◆ Anne had an issue with a guest who was a little unruly, and said she felt bad when management from Ramada Inn called her and told her two rooms had been damaged. Sheila advised that these two issues have been addressed with those particular guests.
- ◆ The security didn't seem to be covering their jobs as well as in the past. Members present at this meeting thought this could be improved. Cookie suggested that members should alert security when needed. Anne agreed. Lynda Justice said that since we are paying for security services, they should be more attentive to their duties.
- ◆ Jonnie Ellington said that sponsors who have donated so much money may feel wrongly about shaggers, and judge all by the actions of a few.
- ◆ Anne said she would like to recognize the major sponsors in a better way other than noting their contributions in the booklet put onto each table. Denise, Carol Oakley., and Brenda also suggested that sponsors should be highlighted in some way.
- ◆ Brenda asked if this was a "shag club" function or a "Meals On Wheels" function. Anne said she thought of it as a shag club event. She recognized that the shag club members did quite a lot of work, and also said that her staff and volunteers did a lot of work also. Ronnie Gregory commented that he thought communications had broken down in that some people did not know what responsibilities were supposed to be handled by whom. Anne said she tried to make it easier by taking care of the money, mailings, and part of the silent auction duties. She noted that MOW had been taking care of any jobs that shag club members did not want to do. Carol said this event should be a partnership and Denise said those who were assigned duties should be responsible for those duties. Anne said MOW wants to help wherever needed. On the evening that mailings were to be processed, only two people showed up to help (Al Fogleman and Charles McKee). It was acknowledged in this meeting that several members had already told Anne or Al that they couldn't be there on that night, but there was still some mis-communication with other members.
- ◆ Joni James said she thought the silent auction could have been better. She took on the duties of chairperson without any guidance from previous events. Members applauded what a good job she did taking on the challenge. Jonnie and Carol said it goes back to the communication. Carol said past chairpersons of each duty should discuss and help the new person in charge. Judy Lindley said it also needed to be decided who is responsible for finalizing the

silent auction bids when the time is up. It was decided that other problems/questions on this committee should be taken up at the designated silent auction meetings.

- ◆ Mailouts - For the 2005 event, there was a pre-mailing to sponsors in October. It has been determined that pre-mailings have not brought in any additional responses. Al said that the same people who give every year still do so - that an earlier letter has not made any difference. To avoid the crunch to get mailings ready, it was suggested that the letters be prepared (printed, stuffed, sorted) earlier and wait to be mailed in January. Al noted that since MOW does a lot for their clients at Christmas, it would be difficult for them to prepare and organize the mailings. It was suggested that shag club members could do more on that.

- ◆ Steve McHone said he and others were disappointed at the exhibition at the mall. There were no banners there for MOW or the shag club. People in the mall had no way of knowing why we were there. There was no one from MOW there to speak. We need to be sure there are banners, signs, and other ways to let people know why we are there dancing. Should also try to plan to be there the week before the benefit. Ron Jefferies asked about selling tickets at the mall. There is a "no solicitation policy" at the mall, so we cannot go out among the crowd and try to sell, but if someone comes to the information table we have set up and wants to buy tickets, we can sell them.

- ◆ Cookie asked that we change our flyer back to "fundraiser" instead of "gala", in order to emphasize that we are holding this event in order to raise money.

- ◆ It was discussed that we should find some way to show how MOW helps people. Perhaps we could make a tape and play it continuously in both the ballroom and DJ room. Lynda Justice suggested that we could take a few minutes before the band starts at 9:00 to recognize ways. Rick Campbell said a presentation would also validate the shag club as a major contributor in the community.

- ◆ The question was asked how the meals are prepared. Ann said she works with caterers and has to deal with them on prices and deliveries to get the best bargain, but still provide a good meal for their clients. Joni asked if there was a most critical time for the MOW budget and Anne said the most needy time was in February.

- ◆ Al discussed briefly past fund raisers and how great this event has grown. He said that it is so well established now that some djs and bands call and ask if they can come because they know of the reputation and how successful this event has been. Al said that people over the state recognize that our club "is" the event. Judy asked what the amount raised this year was. It was \$26,500.

- ◆ Peg asked Al what he saw as pros and cons over the past year. Al said he had grown tired over the last twelve years and should have asked for more help. He emphasized that it is not his benefit, but because he was on the MOW Board, he saw the need and brought that need to the shag club to consider putting on this event. He thanked everyone who had worked on it and put so much time and effort into each one.

- ◆ Tickets - Steve said he thought control of ticket sales could be better. Al said tickets were available at his office (Sawyer Exterminating) and at the MOW office for anyone who wanted to get a pack to sell. Mary suggested that tickets should be available to the officers to give out to members for selling, that members wanted tickets readily available to them, and not have to go and get them. In regards to selling tickets at Master's Lounge, Sheila advised that we could not walk among the crowd and try to sell tickets, but that we could designate one area in the lounge and have someone there with tickets available. Tickets can be distributed and sold at shag club meetings as long as these meetings are outside of Master's Lounge.

- ◆ Lynda said the shag club and MOW has worked together well to put on this event and that we should put aside the bad things and focus on the good things we do and go forward with a positive attitude.

- ◆ A vote to sponsor the event for 2006 will be taken at the next regular business meeting. The date for 2006 will have to be February 18th. The Holiday Band, which already had a contract for 2006, has been notified of the date and advised that this was good for them.

Sheila thanked Anne for all the information on MOW, and thanked those members who took the time to attend this special meeting and express their concerns and suggestions. Meeting was adjourned at 8:30 p.m. Minutes submitted by Evelyn Turner.




