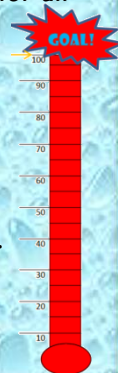
- Butch Dowd, Joan Kimbro, and Edith Loy's aunt passed away 7/21/12.

Lee Neese called the meeting to order at 8:00 PM.

Joan Kimbro welcomed everyone to the meeting.

Secretary's Report: Lorna Shively stated that we now have 266 members (with one member signing up before the meeting - Connor Meehan). Ray Jolly made a motion to accept the minutes as printed for July. Evelyn seconded. All approved.

Treasurer's Report: Amy Crawford presented the 8/17/12 YTD treasurer's report. We started with a balance of \$1123.14 and ended with \$2226.03. Projected expenses for the remainder of 2012 are \$5608.00. Open discussion was held regarding upcoming expenses. We have \$200.00 allocated for the Halloween prizes, which Joan stated would not be needed and another \$500.00 for Christmas Cheer which we will not spend this year due to our finances. Brenda Smith asked that they be removed from the projected expenses. Mary Gregory asked about the \$300.00 allocated for the Fun Monday booth and if that had been voted on. Joan stated that she thought it had been approved when we approved the \$150.00 for the Fun Monday booth rental. Janice McSherry made a motion that this \$300.00 be approved for the purchase of the merchandise for Fun Monday. Sharon Finch seconded. Majority approved. Mary also asked for a detailed listing of the luau expenses. Amy agreed to provide. Sharon Finch made a motion to accept the Treasurer's report and Cindy Swiggett seconded. Majority approved.

Christmas Party: Joan announced that with the Moose Lodge being in negotiations for being sold and other financial considerations, she is looking into other options for the Christmas party. She has discussed renting half of the ballroom with Keith at Ramada. We could rent this for \$100.00 plus costs for bartenders and security. However, in order to get these special rates, we would have to guarantee that 50 rooms would be reserved. She is looking into additional ideas, including having it in Master's lounge at no cost and not having a dinner.

- (2) Distinguished service as an officer and/or committee chairperson of the Burlington Shag Club and/or ACSC/SOS.
- (3) Regular attendance and participation in the Burlington Shag Club and/or ACSC/SOS.
- (4) Distinguished service as a (shag) instructor and/or competitor in local, area, or national shag competitions.

Special Olympics Golf Tournament: Stephen Stearns stated that we have a full complement of teams and we will meet at 8:15 AM at Indian Valley Golf Course. There will be biscuits furnished for breakfast and chicken, salad rolls, etc. for lunch. Members are still being asked to provide desserts in individual servings.

Corn-Hole Fundraising raffle: Evelyn Turner reported that, as of today, we have sold \$2070.00 worth of raffle tickets for the corn hole that will be given away at the SOS golf tournament. Jesse held up one of the boards for everyone to see. Tickets can still be purchased through 8/24/12 and there will be prizes for those who sell the most tickets, if you sold the winning tickets, etc. Tickets will also be sold at the golf tournament, but will not be counted towards the selling incentives.

Fun Monday: Cindy Swiggett announced that we are selling bags, koozies, fans, t-shirts and the corn hole raffle. Cindy also stated that they have several jewelry and other items given to us on consignment to sell. We only have to pay them when/if we sell those items and get to keep a portion of the sales. Mary questioned how much the consignment items were costing us and who had approved it. Joan explained that since no club money was being spent on those items, no approval was needed. Cindy also stated that she still needs volunteers.

Coalition Party: This is being held on the beach on 9/16/12. Danville and Greensboro are hosting the party this year. Remember, no liquor and no glass containers. Sharon Finch mentioned that she is saving beer tabs for the Ronald McDonald house so keep those for her!

Eno Beach Dance contest is this weekend.

Bylaw review: Sheila Walker presented the first bylaw change regarding the dues and time of increase, etc. Kim Sellars made a motion that the dues listed at \$15.00 and \$20.00 in the proposed recommendation be raised to \$25.00 and \$30.00 respectively. Kim rescinded her motion and Cindy Swiggett made a motion that we table the discussion until the next meeting and Mike Wilson seconded the motion. Majority approved. Tommy Stafford made a motion that we have a called meeting on an upcoming Friday night to review and discuss the bylaw recommendations outside of the business meeting since it will take a long time to do this. Doug Foley seconded the motion and the majority approved. Joan will set this up.

Website and bylaws: Sheila asked why the bylaws were removed from the website. Joan explained that at the ACSC meeting they had been told to remove them from the website to prevent unwelcome eyes from having access to this information. For our protection, we should limit what we place on the website. Sheila suggested that we password protect it. Kim Sellars stated that we would have to change the password each year as not all members rejoin. Kim made a motion that we table this discussion to include it in the bylaws special meeting and Lorna seconded. Majority approved.

Burlington Shag Club Hall of Fame



It is now time to consider a candidate to nominate for the prestigious honor of being a member of the Burlington Shag Club Hall of Fame, an award that recognizes hard work, dedication, and contribution to the success of our club. Each year a committee comes together to review and validate the nominations received for this honor. All forms are reviewed for accuracy of information based on the criteria set forth in our Bylaws. The following is the detail from our club bylaws that speaks to the requirements of the Chairperson, the Committee, and the Nomination process:

J. Hall of Fame Committee

1. To have chairperson appointed by the current President. Tenure shall not exceed the term of the current President. The committee, chairperson, or any committee member can be removed by the current President.
2. To be staffed by club members, four required and two alternates, on a voluntary basis. When more members volunteer than required, a drawing of names, from the list of volunteers shall take place. Drawing of volunteer names shall take place during the October business meeting. Alternates would attend meetings but would not vote unless seated.
3. To receive properly endorsed nominations (on the club's nomination form) by October 1st.
4. To have all committee members review, screen, and verify the forms to ensure eligibility and criteria have been met. No more than one (1) person shall be selected for induction in any given year.
5. To preserve the integrity and honor of the HOF as well as the BSC, the committee member volunteer will step down if he or she is nominated. The first alternate will be seated.
6. To have confidentiality remain within the committee. Voting to be by secret ballot and nominees must receive a majority vote to be inducted annually according to the follow criteria:
 - a. Must hold past or current Burlington Shag Club membership.
 - b. Must be fifty (50) years old or older.
 - c. Must have distinguished themselves in the "shag world" for a minimum of three (3) years in three (3) of the four (4) following categories:
 - 1) Distinguished service for the Burlington Shag Club and/or the ACSC/SOS.
 - 2) Distinguished service as an officer and/or committee chairperson of the Burlington Shag Club and/or ACSC/SOS.
 - 3) Regular attendance and participation in the Burlington Shag Club and/or ACSC/SOS.
7. Distinguished service as a (shag) instructor and/or competitor in local, area, or national shag competitions.
8. To meet (after screening of all nominations by the volunteer committee) with the officers by October 31st to review, discuss, and vote on inductees.
9. To recognize all nominees and announce new inductee at the November business meeting.
10. To make inductee lifetime member of the Burlington Shag Club.
11. To recognize the new inductee by their name being added to the club's Hall of Fame plaque.
12. To honor the new inductee with a special ceremony during the Burlington Shag Club Christmas party.

I have left extra nomination forms in the DJ equipment box at Masters so that the form could be readily available to everyone. Please be sure the nomination form is completed with all required signatures in order to be considered and please include a letter of recommendation, detailing your nomination's distinguished service to our club. I will be canvassing the membership present at the September meeting for those who wish to serve on the committee, at which time names will be drawn if more than 4 people volunteer. I look forward to receiving all your nominations.
