30th Anniversary Celebration



This will help out a lot. Also, we have lots of opportunities coming up to earn more money, perhaps cooking shoulders to sell, a putt-putt tournament and a corn-hole tournament.

Bowling: Joan reported that Dianne Neese, Amber Allen, Keith McDole and Luke Coble won the bowling tournament in July and donated the money back to the club. We had 19 teams bowling that night. A great time was had by all!

Costs of events: Joan announced that we cannot continue to have events and charge only \$10.00, especially when the food is costing \$8.50, not to mention the costs of decorations, table/chair rentals and DJs. It will be up to each committee to set the costs, however, we need to make sure that we are giving value to being a member by charging more for non- members who attend these events. The BOD is making this recommendation. Janice McSherry made a motion to make this change on a sliding scale according to the function and related costs. We will increase the existing \$10.00 and the non-member costs to more than the member costs for events (not the luau). Amy Crawford seconded the motion and all approved. Joan also stated that each club will now set the admissions costs of there are club party.

Membership Dues: Joan also reminded everyone that our membership dues are going up in 2016 to try to cover the increasing costs for the club. Memberships will cost \$25.00 and then increase to \$30.00 for those purchased after the cut-off. If you divide this by the number of weeks, it comes up to less than \$.50 per week. These fees pay for the DJ each week, Fastdance and ACSC dues, DJs for special parties and other events and operating costs needed to run the club. If you don't want to join, then you will be charged more at the events. Please let us know about ways to add value to being a member.
