**Lee Neese called the meeting to order at 8:01 PM.**

**Joan Kimbro welcomed everyone present.**

**Secretary's Report:** Lorna Shively reported that we currently have 268 members. She also asked everyone to sign the sign-up sheet if you want to be counted as present. See her after the meeting if you don't see it. Cindy Swiggett made a motion to accept the August minutes as printed in the newsletter. David Sims seconded. All approved.

**Treasurer's Report:** Amy Crawford distributed the YTD report as of 9/28/12. Our starting balance from 8/17/12 was \$2226.03 and our ending balance was \$8440.96. Amy reviewed all of the income and expense items, line by line. Our projected expenses are \$5071.11. Brenda Smith questioned the items still listed as future expenses such as \$200.00 for Halloween Party and \$500.00 for Christmas Cheer. They were voted to be removed at the last meeting. Amy will adjust those budgeted items. Cindy Swiggett made a motion to accept the report and Dave Sims seconded. Majority approved.

**Sunshine News:** Edith Loy reported that Dianne Neese's brother had a heart attack 8/18/12. He had 4 stents put in and is doing well. Mary Ann Lynch had surgery on her hand 8/29/12. Sue Wood had several surgeries at Wesley Long Hospital 9/6/12. She is now at Edgewood for rehabilitation. Glenda White had gallbladder surgery 9/11/12. She is doing well. Louise Flanigan had a heart procedure done at Moses Cone 9/19/12. Doctors said everything went well. Dianne Neese's oldest sister is having some health issues. Charlie McKee is a grandfather for the first time. His daughter had a girl, Marlow Grey, 9/24/12. Congratulations to Charlie and Becky! (Additional concerns post meeting: Kathy Richardson is having a stent put in her leg 10/4/12. Carolyn Williams' mother is critically ill. Gloria Thompson's daughter is having gallbladder surgery 10/9/12.)

**SOS Cards:** Edith also has the 2013 SOS cards. She has 125 to sell and they are \$30.00 each. These make great Christmas presents.

**HOF:** Brenda Smith announced that she needs all of the nominations by Sunday 9-30-12. Lorna suggested that the date might be October 1<sup>st</sup>. The following members volunteered for the HOF committee: Kim Sellars, Sissy Tillman, Betty Caviness, Dianne Neese, Kent Bradsher, Butch Dowd, Edith Loy, Steve Williamson, Steve Pettigrew, Gloria Thompson, Ronnie Gregory and Mary Gregory. These members had their names placed in the basket by the secretary and the names were randomly drawn. The four additional members of the committee are Mary Gregory, Ronnie Gregory, Gloria Thompson and Steve Pettigrew. Alternates are Steve Williamson and Edith Loy. Brenda asked these committee members to meet with her directly after the business meeting to set up next meeting.

**Birthdays:** Joan announced all of our members with September birthdays.

**Fun Monday:** Cindy Swiggett reported that our Fun Monday was a great success this year. We made \$935.00 on the corn hole raffle and sold a total of \$4252.00 worth of items. Our expenses were only \$1242.00, leaving us with a total profit of \$3009.00. We will also get our \$150.00 booth rental fee back from SOS. Cindy and Joan both thanked all those involved with the build of the corn-hole games, selling tickets and working Fun Monday.

**Christmas Party:** Evelyn stated that the Christmas party is scheduled for 12/18/12. Evelyn requested \$1500.00 to be allocated for the Christmas party expenses. Ronnie requested that other expenses be brought back to the club for approval. Evelyn said that the first meeting was going to be on 10/9/12 at 6:30 at Master's. Joan and Evelyn explained that they have contacted several venues, including the Moose Lodge, Shriner's and the Palladium. Several questioned if the Moose Lodge would be available given their recent sale of the property to Integrity church. Joan has spoken to Leonard and he is stated that there will also be an exchange of properties. He does not know if this will take place before our party date or not. If not, we can still have the party at the current Moose Lodge location. If they have moved by that time, we might be able to rent the space in their new location. There is, however, no dance floor at that site. Joan is also looking into other options, including the Ramada. Gary Crawford made a motion that we allocate the \$1500.00 in order for the committee to begin planning and reserve a site as decided, with a caveat that once the venue costs are determined, additional expenses above the \$1500.00 be brought back to the club for approval as needed. Janice McSherry seconded the motion. Majority approved. Additionally, Evelyn needs four DJs recommended for this party so that the club can vote on them. Rick Turner, David Tuttle, Jim Waye and Chigger Woods were nominated as choices. Rick Turner had the most votes with 28, David had 14, Jim received 4 and Chigger received 7. Evelyn will discuss this with Rick to see if he can make this date. If not, she will move to the second choice, David Tuttle.

**Halloween Party:** Sissy Tillman and Steve Williamson are in charge of this party. The Halloween party will be held on 10/26/12 at Master's lounge. There will be a contest for Best Female, Best Male and Best Couple costumes. Aldo, there will be door prizes given, many of which were donated. Mary Gregory made a motion to approve the door prizes and Butch seconded the motion. Majority approved.

**Meeting:** Joan stated that during SOS, the presidents/representatives of that coalition clubs had a meeting to discuss our annual parties. First question asked was if we wanted to continue to be in a coalition? Amy Crawford made a motion to continue in the coalition and Brenda Smith seconded. All approved. We currently have one party per club each year. Sometimes it is hard to support other clubs parties, but we should make the effort since they support ours. Perhaps we can join with other clubs to put on a joint party? They discussed doing this at that meeting, asking if we'd do better having two clubs partner up to give one party instead of two. Each year you would rotate the location with your partner club. Open discussion was held. We wouldn't have to give up our luau, but have it as a party and not our area party. Do we want to do this and add another party to our schedule? Everyone agreed that we did not want to cease our luau, but that we really didn't have time or energy left for planning a second party. Mike Wilson asked why the coalition couldn't have just one large party, with each club rotating each year to host it. Majority voted to keep things as they are now.

**Christmas Cheer Yard Sale:** This is coming up next weekend, on 10/6/12. The trailer is at Stearns Ford and we still have plenty of room for you to bring your things out. Joan has several large items being donated, but they will not be delivered until Friday due to their size. We will meet mid day on Friday 10/5/12 to start setting things up and pricing. **MOW:** Stephen has already met with Anne from MOW. This will be our 20<sup>th</sup> year hosting the MOW party/fundraiser in February and MOW will be celebrating 40 years. Anne wants to make this one a glitzy party. The first meeting is 10/18/12 at 6:30 at Master's.

**By-Laws meeting:** Joan stated that she has been trying to get this meeting scheduled with Sheila, but she has been very busy and this is on hold until she can fit it into her schedule.

**Pat Gumula won the 50/50 \$800.00+ at the Coalition Beach party. She has graciously donated \$100.00 back to our club. Evelyn Turner won \$2000.00 at the Fun Monday drawing and Chuck Upchurch won the corn hole boards which were raffled by our club on Fun Monday.**

## Special Called Meeting for Burlington Shag Club

**10/5/12 at 8:00 PM**



**A special called meeting was held at Master's Lounge at 8:00, PM with a quorum present.**

**Lee Neese called the meeting to order at 8:00 PM.**

**Joan welcomed everyone and asked that she be allowed to speak first and take questions after she has explained the reason for the called meeting and everything that has happened this week.**

Joan announced that Master's Lounge will be closing at the end of this month. Joan stated that she was called to a meeting last Monday and told that Ramada is doing some renovations and remodeling. Most of this is due to making the bathrooms handicap accessible, but they will be removing the wall between the ballroom and Master's and extending the dance floor so that there will be a dance floor at both ends of the ballroom. They will NOT reopen Master's Lounge, but will put a small bar in the restaurant area for hotel patrons. The owners have made this decision and it had nothing to do with the BSC or anything that we have done. We will know the final date that we can use the lounge after the contractors have met and decided on the schedule, but we should be able to meet there through the end of this month and have the Halloween Party there.

Joan reminded everyone that our club has been going strong for 27 years and we will continue on together as a club. She has spent several days looking into other options around town and has several leads and interested parties that she is in preliminary discussions with. We will have 9 weeks (Friday nights) for which we will need to find somewhere to meet. Keith, with Ramada, has offered us the Carolina Room for \$100.00 for the nights that are currently available, if we choose to book them. There are already 3 Friday nights that the room is already booked for: 11/2, 11/9 and 12/7. They will continue to accept bookings on this room until we lock those dates in. With the holiday season upon us, they may not stay available long. If we don't do this, we would possibly have to pay higher rent somewhere else and charge a cover charge at the door. This \$100.00 is in addition to the \$100.00 we already pay for the DJ services each week.

She has also spoken with representatives from the bowling alley (lounge) and Yesterdayz. If we were to use Yesterdayz, we would have to purchase a full ASCAP license and alcohol or beer license. He said that he would charge a cover charge at the door and that he would keep that for the rental fee. The representative from the bowling alley has not gotten back with her, but was going to have to ask her bartenders if they were ok with an influx in volume and Joan is also unsure about the ASCAP license. She has spoken to the Cutting Board which seems to be a really good fit for our club. They are interested in having us there and are considering this option for us, but need to discuss with the other partners. Currently, they are already booked each Friday night through the end of the year. If they approve of a plan for us to meet there, it would not begin until January, 2013. They have all of their licenses, so we would be covered for that.

This is a set-back, not a defeat. We are going to stay a strong club through this time. We are still one of the few clubs who has not had to meet at a place that charges rent or a cover charge at the door. If we vote to book the Carolina Room for the available Friday nights for November and December, then we have until the end of the year to find a new home for our club. She called this meeting so that we could all hear this at the same time and from the same source so that there would not be any misunderstandings about what was happening and why.

#### **Joan opened the floor for discussions:**

Will this affect MOW in February? Joan said that Keith told her that this should not affect the MOW party in February. They hope to have all of the renovations made before the big New Year's Eve party.

#### **Friday night meeting options:**

1. Have we looked into the Moose Lodge since they are talking about switching properties with the church that wants to purchase their property? They are going to be voting on this next week.
2. Is 333 an option? No, because we would have to purchase an ASCAP license.
3. Yesterdayz – They do not have the ASCAP or alcohol licenses. Would charge door fee.
4. Bowling Alley lounge---unsure of licenses, bartending and the parking lot there is highly policed.
5. Carolina Room---If we pay Ramada \$100.00 for the use of the room, would we need to charge a cover charge at the door? What happens if we lock in the 6 available nights and find a new place to meet before the end of the year? Will we still have to pay? Yes.....per the contract that we would sign to reserve those dates. Also, we could be charged \$10.00 per hour (3 hours) for a bartender for that room. However, Nita is working to see if she can have the portable bar put in there for our reserved nights, which would eliminate that cost.
  - a. Carolina Room for dance nights---Steve Williamson made a motion that we reserve the 6 nights available for the Carolina Room and Cindy Swiggett seconded. Majority approved (no dissenting votes). Evelyn Turner suggested that we charge a \$3.00 cover charge at the door for the nights that we rent the Carolina Room for our regular dance nights. This will help to cover our rental fee and perhaps bartenders, if needed. Hugh Walker made a motion to charge \$3.00 at the door and Steve Williamson seconded. Majority approved (no dissenting votes). If we don't have enough funds to cover the rent and the bartender we will either take up donations or use club funds to bridge the difference. We can also sell 50/50 tickets in the hallway outside the room to help cover the costs. We cannot sell them in the room because alcohol will be present. If there is any overage between what is collected with the door charge and the 50/50 ticket sales, it will go into the club treasury.
  - b. Christmas Party---The Carolina Room is currently available for the 12/8/12 date we have scheduled for our party. Nita said that she can get that room for \$300.00, but Joan stated that Keith had quoted her a lower price, something about linen fees only. She will look into this and confirm the pricing for that night. The Christmas party committee will look into this, along with the costs of any food that we may need to purchase through Ramada. The holiday season is booking up fast and we will need to make a decision quickly if we want to do this. Cindy Swiggett made a motion that we reserve the 12/8/12 date for the Carolina Room and Wade Kimbro seconded. Majority approved (no dissenting votes). The Christmas party committee will have their first meeting on 10/9/12 at 6:30 at Master's to begin planning and working out the details.

Joan asked if we wanted to form a search committee to look into another venue for us to meet after 2012. Volunteers were taken and they are: Kim Sellars, Baxter Sellars, Cindy Swiggett, Carol Pettigrew, Sheila Walker, Hugh Walker, Sissy Tillman, Ronnie Gregory and Mary Gregory. They will have a meeting directly after this meeting to decide on a time and date to meet up and discuss a plan of action. Sheila asked that Joan send them a listing of the questions and issues that need to be asked and resolved with each venue option or candidate that is contacted.

**Remember that the Board of Directors meeting is 10/10/12.**

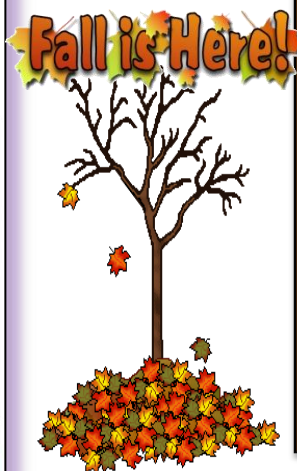

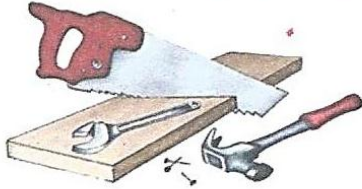
